## Pastor's Message

*"Let there be light."*

Grace, mercy and peace to you from God our Father and the Lord Jesus Christ.

Genesis Ch. 1 has long been a favorite of mine, and I would suspect many of you have the same sentiments. Our ancient forefathers in the faith felt similarly, finding there great depths of meaning within these sacred pages. In more modern times however, readers who've attempted to sail across the depths of Genesis have been more or less sidetracked by external concerns which are foreign to the deeper interests of God's purposes in the Sacred Scripture, and therefore have failed to immerse themselves or even to discover these great depths. Over the years I've noticed many people who seem to be altogether preoccupied with the *length* of the days of creation. They would ask questions like, *"Is it really necessary to think of those "days" in the sense of having 24 hours? Might they rather represent long eras of natural history?"*

No. No matter how much we may want to, we cannot claim that this is what the biblical Author had in mind in revealing this part of history to us. The trouble with such questions is that they ultimately distract the mind of the reader from the deeper message of the Word of God. Simply put: To ask how long the days of creation were, is a fruitless endeavor and an unnecessary distraction. The intention of Genesis 1 is not to invite a discussion about *How God could do all of this stuff in so short a time? –or- How long were days before God created the sun and moon? –or- Whatever!* --The intention of Genesis 1 is to show us that it was God who created.

Further, in the story of creation the rising and setting of the sun are not what determines day and night. Regarding the first day we are told that, "there was evening and there was morning" and yet the sun hadn't even been formed! How in the world can there be evening and morning without the sun rising and setting? And therein lies the problem. We moderns generally think of the sun's rising as making day and the absence of the light as making night. The Sacred Scripture and our early brothers and sisters would have thought this to be a rather shallow definition and causation for day and night. They knew that the sun rises and sets, evening and morning comes and goes, indeed all of creation is held together only by the Word of God spoken in the beginning. In the Scripture, the sun only *marks* the day, it does not cause nor create it. The "day" is still there; it still happens, with or without the sun.

God opened his mouth and light emerged three days before he created any of the stars or sun or moon, etc. So light and darkness in Genesis, as well as today, exist independently of the sun or any other cause we may have ascribed to them.

It's also interesting to notice that Genesis does not say that God created darkness. Darkness was in a sense already there--it was the void. For those of you who remember the movie, *The Neverending Story* and "the nothingness" in that movie-- darkness is nothingness. The "night" of creation is essentially nothingness. And this is of course why the book of Revelation, when it speaks of heaven, tells us, "There shall be no night there".

Light is the first thought of God in regard to creation. The very first recorded words of God to us are, "Let there be light". And this light in Genesis is not a by-product of the sun or any other heavenly body. The light that God calls forth to shine in the created universe is the light of the eternal Son, Jesus. *Again Jesus spoke to them, saying, "I am the light of the world. Whoever follows me will not walk in darkness, but will have the light of life."* John 8.12 It's only by this Light which proceeded from the Father at creation that anything in creation can be and is illuminated – spiritually, intellectually or otherwise.

The modern culture as a whole, or at least a significant part of it, believes that our purpose is to give meaning to the world around us; to "make sense" of it, however, the Word of God bids us to pursue and discover the meaning that is already there. The modern mind ultimately comes to this conclusion because it doesn't any longer believe that the world was in fact created at all. Our sense of wonder at the creation has given way to the formation of the universe as a result of random physical forces and arbitrary explosions of energies. The modern and rather mundane world cares little or nothing of the "why" of creation only of the "how". This is to say that the only light which *it* recognizes and is able to possess is physical light. And so the mind is left in darkness; an existence that is forever outside of the Light of the world. In this sense, modern man's situation is grimly like that of Judas Iscariot-- *"So, after receiving the morsel of bread, he immediately went out. And it was night."* John 13.30

My sisters and brothers, let your light so shine before others that they may see your good works and glorify your Father in heaven.

## CHURCH COUNCIL MEETING

May 20, 2018

### MINUTES OF MEETING

**Devotions:** Prissy Helms opened the meeting with a devotional reading and prayer.

**Roll call and action on excuses for absence:**

**Present:** Pastor Frye, Judy Abernathy, Michael Dukes, Tommy Hedrick, Prissy Helms, Crystyl Human, Joe Keefer, Leonard Lewis, Pat McAlister, Richard Medlin, Nancy Olls, Laura Olls, Brian Robinson, and Tonya Stone

**Absent:** Judy Ray

**Minutes of last meeting:**

1) The minutes of the April 8, 2018, Council meeting were approved as written. Tonya made a motion to accept the minutes. Pat seconded the motion. The motion was approved unanimously.

2) The minutes of the April 22, 2018, Called Congregational Meeting was approved as written. Leonard made a motion to accept the minutes as written. Prissy seconded the motion. The motion was approved unanimously.

3) The minutes of the May 6, 2018, Called Congregational Meeting was approved as written. Leonard made a motion to accept the minutes. Crystyl seconded the motion. The motion was approved unanimously.

**Reception of petitions and communications and new business:**

1) Terri Hedrick is a trustee for CELC. She has asked that Kim Costner be able to substitute for her in the event that she cannot be present. Leonard Lewis made a motion that we accept Kim Costner as a substitute trustee. Tonya seconded the motion. The motion was passed unanimously.

**Report of the Pastor:** Pastor Frye brought the following matters to Council for discussion and /or informational purposes.

1) Report of pastoral activities for the month of April, 2018. Pastor Frye presided over the Divine Service 6 times, taught Bible Study 5 times, taught Sunday morning Bible Study 6 times, attended Pericope Study 2 times, had 14 pastoral contacts, and attended 3 meetings.

2) Pastor Frye has extended an invitation to T. C. Plexico to be our Homecoming preacher, which he gladly accepted.

3) Pastor Frye has almost completed a thermometer-style graph to display in the Narthex that will keep people abreast of how much money we have raised for the FLC replacement floor. He needed to know our goal in order to complete it.

4) The new communion-ware will be ordered this week.

5) Pastor Frye has informed us that the following people have been elected to serve on the Executive Council of the NALC. They are:

- a) The Reverend Heidi Punt- Christ United Lutheran Church, Granite Falls, NC
- b) Lin Donnell-Advent Lutheran Church, North Charleston, SC
- c) Dennis Bollinger-New Jerusalem Lutheran Church, Hickory, NC

6) Pastor Frye has informed us that a big topic at the NALC meeting was "restructuring". Our Bishop and Deans are extremely overworked. A committee is being put together to explore dividing the oversight of the NALC into different regions, each being presided over by a regional Bishop, who will be appointed by the presiding Bishop.

7) The Mission District budget of \$45,450.00 for 2018 was approved. Another \$5,000.00 was approved for the Dean's Discretionary Fund, and \$3,000.00 was approved for the task force to study restructuring (mainly travel expenses).

8) Pastor Frye has informed Council that he will be taking Monday and part of Tuesday (21<sup>st</sup>, 22<sup>nd</sup>) off. The last week has been non-stop and he needs a break.

**Reports by General and Capital Fund Treasurers:**

- 1) Michael presented the April, 2018 financial report for the General Fund to Council members for review and discussion. He also presented the Designated Funds report for April, 2018. Michael reminded us that any payments to individuals must go through the General Fund for tax purposes. These types of payments should not be written from the Memorial Fund.
- 2) Crystyl presented the April, 2018, Capital Fund Report. We have received \$4,020.00 toward the FLC floor.

**Reports of Standing Committees:**

**Archives/Communications:** Richard reports that there is a plaque with the names of our World War II veterans on it that usually hangs in the hallway. It has been removed by Sally for needed repairs. The original name-plates were done in paper and are degrading. Sally is hoping to replace the names with engraved brass plates. Sally wants everyone to know that anytime anyone wants to check out the Archives, they can do so.

**Christian Education:** Tonya reports that there will be no summer Sunday school. Enjoy your summer!

**Endowment: No Report, Evangelism: No Report, Finance/Stewardship: No Report**

**Internal Ministry:** Prissy reports that:

- 1) Graduates for 2018 are Jay and Emma Human. There will be cookies and punch after the church service on June 3, 2018.
- 2) The Alter Flowers system needs to be revamped. Prissy states that there will be a Flower Calendar to sign up to order altar flowers. Anyone who signs up to sponsor flowers will have to pay for them before they are ordered

**Mutual Ministry:** Pat reports that a meeting was held last week. The committee has started employee reviews. They meet again on Tuesday, May 22, 2018.

**Property Committee: Brian reports that:**

- 1) The first aid kit boxes have been received. There are three of them, one each for the church, the family life center, and the education building.
- 2) The see-saw in the playground area has been disconnected and will be moved.
- 3) The church fire extinguishers need to be inspected and recharged.
- 4) The new doorbell with camera has been ordered.
- 5) There is a piece of wood on the front of the church that needs to be repaired. Casey (subcontractor) will be contacted to complete this work.

**Social Ministry: No Report. Stewardship: No Report. Worship and Music: No Report**

**Youth: Laura reports that:**

- 1) She is working on the new schedule for acolytes and crucifers.
- 2) Acolytes and Crucifers need reminders! Julie is supposed to send reminders to acolytes and crucifers, but needs phone numbers in order to remind everyone.
- 3) Pastor Frye wants to go on an outing with the youth group. He would like to take them bowling!



### **Report of Special Committees:**

1) The Cemetery Committee progress notes were presented to Council for review and discussion. Bob Mahovsky wanted to know how much money he could expect from CELC. Leonard made a motion to donate \$3,000.00 from the CELC. Pat seconded the motion. The motion passed unanimously

2) The Website Committee progress notes were presented to Council for review and discussion. They would like to have our sermon's posted online. Five to six sermons can be stored on our present system, unless Pastor Frye shortens them. There was a question about whether Bible Studies could be posted online. Once again, it takes a lot of memory. Council will follow up on this next month.

### **Other Reports: Safety and Security Committee**

1) The video doorbell has been received

2) Three first aid kits have been received.

3) A CPR class will be held at CELC for all members. This will probably be held on a Sunday afternoon. If you do not know CPR, or are just out of date, please plan on attending this very important class. **EVERYONE** should know CPR!

### **Unfinished Business:**

1) **Family Life Center Floor:** The floor has been started. \$11,500.00 has been paid. The total should be \$31,000.00. With new cove-base, it may be just over that amount. We are asking for donations until Homecoming. Council is considering a silent auction to raise funds. A coordinator is needed for the silent auction.

2) **Lutheran World Relief:** Leonard reports that the LWR is working with coffee farmers to keep the middleman out and allow the farmers to reap more profit. This allows the farmers to support their families. Coffee may be purchased from Leonard. He will order it and have it for us to buy.

3) **Clean Water:** Water Missions International reports that 40 water systems are needed in Puerto Rico after the hurricane devastation. Approximately 25 have been completed.

4) **Lutheran Women:** The annual meeting of Lutheran Women will be held in Concord on September 29, 2018.

5) **NALC Finances:** Pastor Frye reports that the NALC is not receiving the amount of money it needs from some other churches. We presently give 3%. Leonard made a motion that we raise that to 5% in our next budget. If we raise our level to 5%, 3.5% goes to National, and 1.5% will go to our district. Presently, all of our benevolence goes to National. Michael will report at our next meeting if this would be possible.

### **New 2018 Council Business:**

1) David and Leonard will open and close the church in June and July, 2018. Thanks, David and Leonard!

### **Adjournment:**

1) The next council meeting will be June 10, 2018, at 6:00 PM. Tonya will lead devotions.

2) The meeting was adjourned following The Lord's Prayer.

### MINUTES OF MEETING

**Roll call and action on excuses for absence:**

**Minutes of last meeting:**

1) The minutes of the May 27, 2018 called Council meeting were approved as written.

2) The minutes of the June 3, 2018 called Council meeting were approved with one correction.

Leonard made a motion to accept the minutes for May 27, 2018 as written and June 3, 2018 with one correction. Crystyl seconded the motion. The motion passed unanimously.

The minutes from the May 20, 2018 Council meeting will be reviewed at the next Council meeting.

**Reception of petitions and communications and new business:**

1) Judy Abernathy has asked that the pews in the Education building be cleaned. The pews in the church were done last year, but the pews in the Education building were not. A motion was made to have Rick Chapman check on getting these pews cleaned. Prissy made a motion to have them cleaned. Before a vote was taken, Pat volunteered to clean them before we pay someone to do it.

2) Council reviewed the annual staff reports for church employees. All employees were rated "very good". Judy Abernathy made a motion to accept the reviews as written. Joe seconded the motion. The motion was passed unanimously.

**Report of the Pastor:** Pastor Frye brought the following matters to Council for discussion and /or informational purposes.

1) Report of pastoral activities for the month of May, 2018. Pastor Frye presided over the Divine Service 3 times, taught Sunday Bible Study 3 times, taught Wednesday Evening Bible Study 3 times, had 10 pastoral contacts, and attended 2 meetings. He presided over the Rite of Christian Burial of Eddie Wyatt. He also attended the funeral of Lisa Caudle's father, Joe Guthrie.

2) The 2018 NALC Convocation is August 13-17, 2018 in Denver. When the bishop was asked if we would continue to have *annual* church-wide convocations, he discussed how it was necessary for the nascent years of the church, with all that is involved in establishing a new church body, to meet every year. However, he also believed the convocations could soon (possibly within the next several years) be moved to every other year.

3) **For our new Council members.....**though we are afforded one lay voting delegate for every 400 members, we have not exercised that right in the past because of both the great amount of time and the cost of travel, room, and board. We need to decide what to do by next Council meeting.

**Reports by General and Capital Fund Treasurers:**

1) Michael presented the May, 2018 financial report for the General Fund to Council members for review and discussion. He also presented the Designated Funds report for May, 2018. Michael also presented information regarding benevolence to the NALC. We will begin donating 1.5% to the local Carolina Mission District. We will also donate 2.0% to our National Church.

2) Crystyl presented the May, 2018, Capital Fund Report.

### **Unfinished Business:**

1) **Family Life Center Floor:** The original contractor (Jack Severens) for the new Family Life Center Floor failed to live up to expectations. Council has decided to sever ties with him and request a \$15,000.00 refund of the \$23,000.00 he has been paid. Council feels that Jack knew the condition of the concrete before he started. After receiving a new estimate from Concrete Coatings of the Carolinas, a company that specializes in large floors, Council feels that it is fair for Jack to keep \$8,000.00 for his materials needed to complete the first coat, which can be utilized by the new contractor. If Jack balks at the \$15,000.00 refund, Council will have no other choice than to hire an attorney to attempt to receive a full refund of the \$23,000.00. Some members of Council will visit warehouses that have been done by Concrete Coatings of the Carolinas, to check out their work. Joe made a motion to cut ties with Jack, request a refund, and hire Concrete Coatings of the Carolinas if we are happy with what we see at the warehouse visit. Leonard seconded the motion. The motion passed unanimously. Council will move forward after the warehouse visits.

### **New 2018 Council Business:**

- 1) David and Leonard will open and close the church in July and August, 2018. Thanks, David and Leonard!

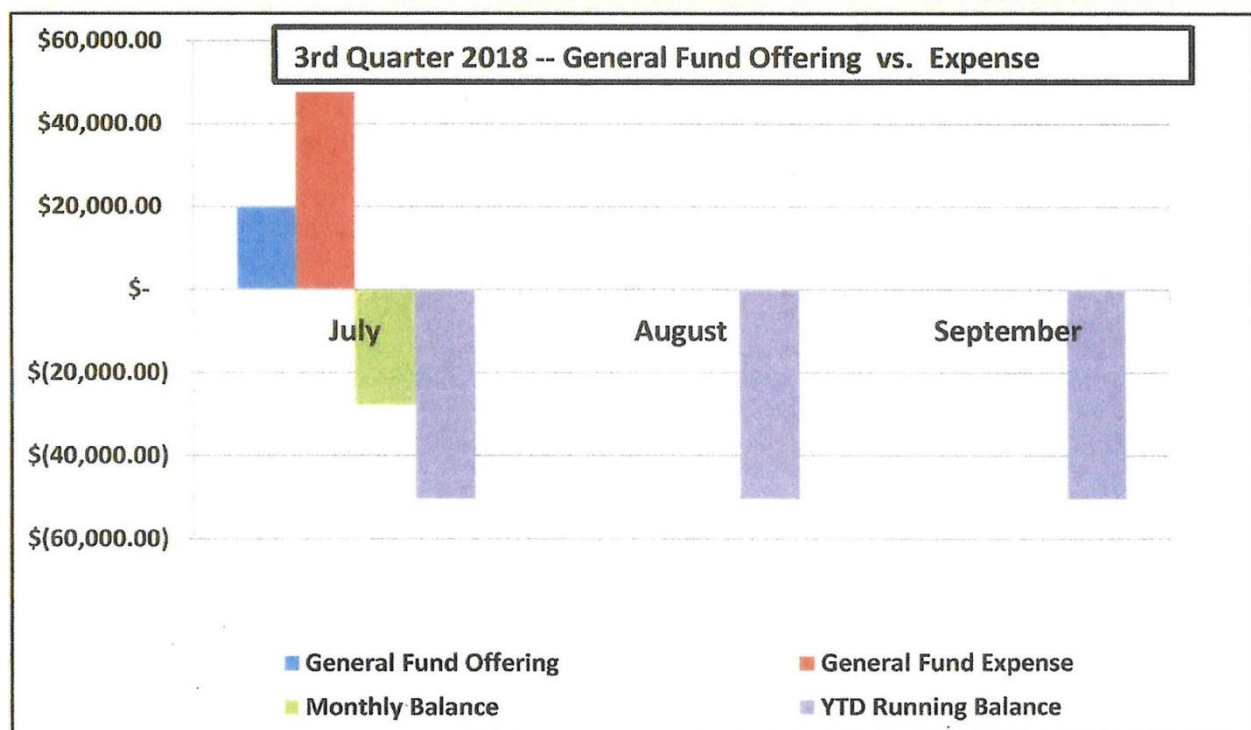
### **Adjournment:**

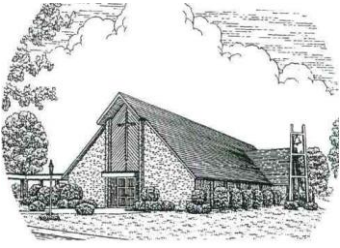
